Visit Philadelphia's "Pack Light. Plan Big. Summer Giveaway" Sweepstakes Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. THIS SWEEPSTAKES IS INTENDED FOR PLAY IN THE UNITED STATES ONLY AND WILL BE GOVERNED BY U.S. LAW. DO NOT ENTER IF YOU ARE NOT ELIGIBLE AND LOCATED IN THE UNITED STATES AT THE TIME OF ENTRY.

1. **OVERVIEW.** Visit Philadelphia's "Pack Light. Plan Big. Summer Giveaway" Sweepstakes Official Rules (the "Sweepstakes") is sponsored by Greater Philadelphia Tourism Marketing Corporation d/b/a VISIT PHILADELPHIA® ("VISIT PHILADELPHIA" or "Sponsor"). The Sweepstakes begins on Friday, July 23, 2021, at 8:00:01 am Eastern Standard Time ("EST") and ends on Wednesday, August 18, 2021, at 11:59:59 EST (the "Sweepstakes Period"). The purpose of this Sweepstakes is to further VISIT PHILADELPHIA's mission of promoting the City of Philadelphia and the region to attract tourists. ENTRY IN THIS SWEEPSTAKES CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES.

2. **TO ENTER.** During the Sweepstakes Period, you may enter the Sweepstakes by completing one of the following:

- a. **Online Entry:** Eligible individuals may visit www.visitphilly.com/summergiveaway and complete and submit a Sweepstakes entry form. The entry form must be completed with correct information to be valid. Submitting a completed entry form in accordance with these Official Rules will grant eligible individuals one (1) entry into the Sweepstakes. There is a limit of one (1) entry per person, per day throughout the Sweepstakes Period. You may earn additional entries by taking prompted social media actions in the online Sweepstakes form at the original time of entry (e.g., follow Visit Philadelphia's Instagram account @visitphilly; follow Visit Philadelphia's Instagram account @lovegritphilly; follow Visit Philadelphia's Twitter account @visitphilly; "like" Visit Philadelphia's Facebook page). Those who do not follow all of the instructions, provide the required information in their entry form, or abide by these Official Rules or other instructions of Sponsor may be disqualified. Any use of robotic, automatic, programmed or similar entry methods will void all such entries by such methods.
- b. **Alternate Means Of Entry:** During the Sweepstakes Period, you may alternatively submit an entry to the Sweepstakes by mailing a standard-size postcard with your full name, street address, city, state, zip code, email and telephone number to: "Visit Philadelphia's Pack Light. Plan Big. Summer Giveaway", c/o OPE, 30 S. 15th Street, Floor 15, Philadelphia, PA 19102. You must also indicate the Sweepstakes Period associated with your Entry. Mail-in Entries must be received within the Sweepstakes Period. Only potential winners will be notified by email or telephone. Sponsor is not responsible for lost, late, incomplete, invalid, damaged, unintelligible, illegible, misdirected or postage-due mail-in entries, all of which will be disqualified.

3. **BINDING AGREEMENT.** In order to enter the Sweepstakes, you must agree to these Official Rules. Therefore, please read these Official Rules prior to entry to ensure you understand them and agree to be bound by these terms. You agree that submission of an online entry form in the Sweepstakes constitutes an agreement to be bound by these Official Rules. You may not submit an entry form to the Sweepstakes and are not eligible to receive the prize described in these Official Rules unless you agree to these Official Rules. These Official Rules form a binding legal agreement between you and VISIT PHILADELPHIA with respect to the Sweepstakes.

4. **ELIGIBILITY.** The Sweepstakes is open only to legal residents of any of the fifty (50) states of the United States or the District of Columbia (excluding Puerto Rico and U.S. territories) who, as of the date of entry, are 21 years of age or older. Employees of VISIT PHILADELPHIA and its advertising agencies, promotion, fulfillment and other coordinating agencies, and the immediate family members and/or household members of any such persons or entities are not eligible to participate in the Sweepstakes. The Sweepstakes is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

5. **ODDS OF WINNING AND WINNER SELECTION.** On or about August 19, 2021, VISIT PHILADELPHIA will select one (1) winner by random draw from among all eligible entries received during the Sweepstakes Period. **Odds of winning depend on the number of eligible entries received.** VISIT PHILADELPHIA, in its sole discretion, reserves the right at any time to disqualify any entry or entrant that fails to comply with these Official Rules. VISIT PHILADELPHIA's determination of the winner is final and binding. The potential prize winner must meet all eligibility requirements and fully comply with these Official Rules.

6. **WINNER NOTIFICATION.** The potential prize winner will be notified by VISIT PHILADELPHIA via e-mail or phone on or about August 19, 2021. Potential winner is subject to verification, including verification of age. Except where prohibited by law, the potential winner will be required to sign and return an affidavit of eligibility and publicity/liability release within 48 hours of notification and provide any additional information that may be required by VISIT PHILADELPHIA. VISIT PHILADELPHIA shall have no liability for any potential prize-winning notification that is lost, intercepted or not received by any potential winner for any reason. If a potential winner cannot be contacted, is ineligible, fails to claim a prize and/or where applicable an affidavit of eligibility and publicity/liability release is not timely received, is incomplete or modified, the prize may be forfeited and an alternate winner may be selected from remaining valid, eligible entries timely submitted. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized account holder of the e-mail address connected with the completed Sweepstakes entry form. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Sponsor is not responsible for any change of email address, mailing address, and/or telephone number of entrants.

- g. Two tickets to Museum of the American Revolution (\$38 value)
- h. Two tickets to the New Hope Railroad (\$150 value)
- i. Two two-day Philly PHLASH Downtown Loop passes (\$18 value)
- j. \$25 Independence Gift Shop gift card
- k. Incentive to Return: Two tickets for Beautiful: The Carole King Musical, Academy of Music, Tuesday, February 22, 2022 (\$199 value)

The prize has a total ARV of \$1,946. The prize winner is solely responsible for all expenses not listed in these Official Rules, including any travel expense and parking (not included in the VPOHP), and for payment of any applicable federal, state, and/or local taxes.
